**Location:** The Frank Family Farm is located in the Panhandle of Western Nebraska approximately three miles South and two miles east of Mitchell, Nebraska. Mitchell is a smaller rural town with a population of approximately 1,800 individuals with K-12 schools. The combined towns of Scottsbluff and Gering are located seven miles east of Mitchell with a population of over 20,000 residents, a regional hospital, junior college and several shopping centers. This is the major shopping center for the surrounding area. There are many Ag related businesses located here with an active livestock auction facility, equipment dealers and repair shops to meet the area's farmer's needs.

**Farmland:**

The farm is comprised of one field made up of a large majority of sandy and silt loam soils. Referring to the enclosed Soils Map these are Class I and Class II irrigated Soils, the very best soils for raising all types of locally grown valley crops.



**Irrigation Well:** County Rd 16, a non maintained county road forms the one half mile long west boundary of the farm. The electric powered irrigation well adjoins the road 16 approximately half way between the north and south boundaries of the farm.

The well registration number through the North Platte Natural Resources District is G-047090. NRD well information states that the well was drilled on 11/20/1986, has a total depth of 60', static water level 13' and the pump is setting at 25.' The column is 8" and when it was tested it pumped 1,200 gpm. This well is certified to irrigate 106.6 Acres the same as the total amount of farmland on the Frank Family Farm.

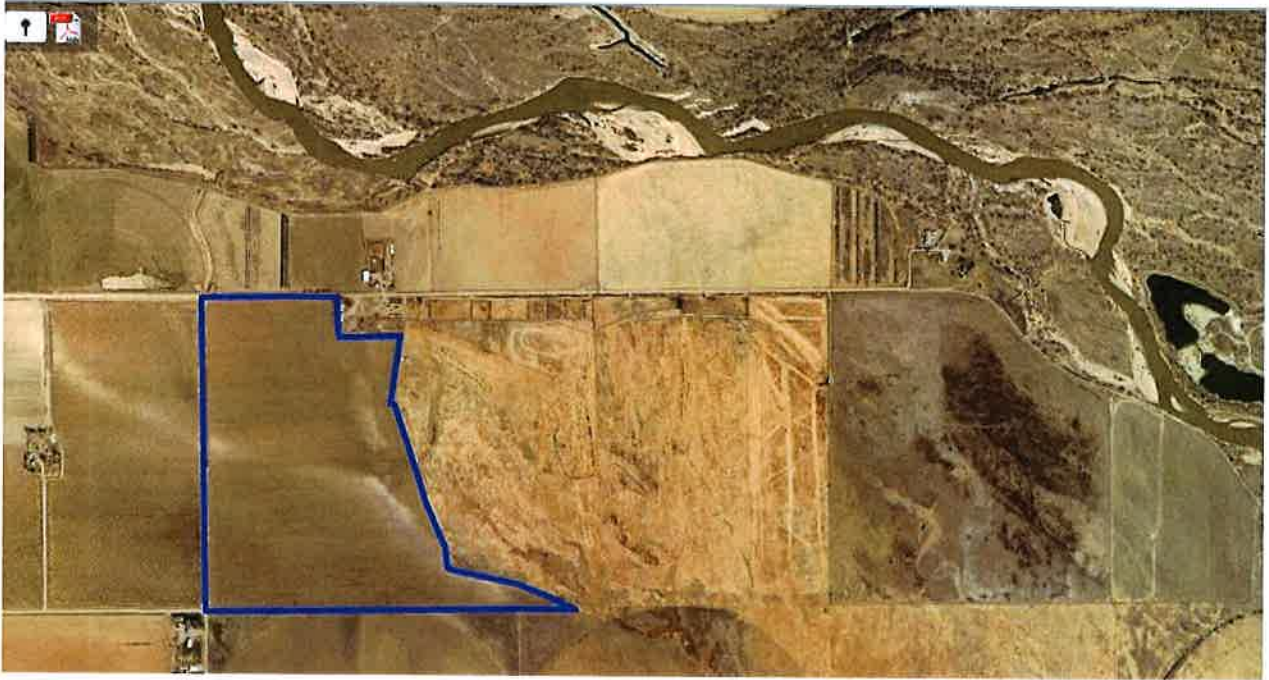
**Mitchell Irrigation District:** There are also 106.6 Acres of certified irrigated Acres under the Mitchell Irrigation District with an annual assessment of \$2,400.00. The Mitchell Irrigation District is a reliable source of irrigation water but, the addition of the irrigation well is a good insurance policy in case the irrigation district has a short year of runoff from the mountain snowfall or some other factor causes a shortage of water.

**Wildlife:** Migrating ducks and geese stop and spend most of the fall and winter months in the area around the North Platte River feeding on grain left in the fields after harvest. The North Platte River is less than a quarter of a mile from the farm. Needless to say there is excellent hunting on the Frank Family Farm.

**Winter Pasture:** The crop residue left from the fall harvest has been used local livestock producers for late fall and winter pasture for their livestock providing added income for the farm owners.







**The approximate distance from the Frank Family Farm to the North Platte River is 1,000 feet. Which is less than a quarter of a mile. Waterfowl utilize the river as a resting spot and then feed on the harvested corn fields later in the day or early in the mornings.**
